Unit 1: Principle of Domestic Violence

Unit 4: Future of Domestic Abuse

This unit will evaluate the current approaches to DA prevention and reduction, in order to understand the challenges and problems. This will serve to build an appreciation of new strategies and plan with increased efficacy and suitability. Furthermore, the concept of Multi-Agency Networking is discussed in-depth with plenty of examples.
